ORDER

Provisional Affiliation was granted to start a new Architecture College viz. Nehru College of Architecture, Lakkidi, Mangalam, Palakkad under Nehru College of Educational and Charitable Trust, Pampady, Thrissur, with B.Arch programme (40 seats) during the academic year 2015-16 vide U.O read as 1st above, in the light of the Interim Orders of the Hon'ble High Court of Kerala in WP(C) No. 29326 of 2015 and WP(C) No. 29356 of 2015 dated 28.09.2015, subject to the disposal of the Writ Petition .

- 2. Vide U.O read as 2^{nd} Continuation of Provisional Affiliation was granted to the B.Arch Programme with an intake of 40 students for 2022-23, on conditional basis, subject to the submission of the renewal NOC from the Government and is made absolute as per the orders from the Government exempting NoC for 2022-23 to the member colleges of Architecture College Managements' Association (ACMA), vide U.O read as 4^{th}
- 3. The Principal has applied for Continuation of Provisional Affiliation to B.Arch programme for the academic year 2023-24, vide paper read as 3^{rd} by remitting Rs 3,52,800/- (Rupees Three Lakh Fifty Two Thousand Eight Hundred only) towards Administration and Affiliation fee .
- 4. The College has submitted the Extension of Approval Order from the Council of Architecture for the academic year 2023-24 with an intake of 40 seats, vide paper read as 5th above.
- 5. Considering the above, the Vice Chancellor has accorded sanction to grant Continuation of Provisional Affiliation to the B.Arch programme with 40 seats at Nehru College of Architecture, Lakkidi, Mangalam, Palakkad for the academic year 2023-24, on conditional basis subject to the submission of renewal NOC from Government.
- 6. Orders are issued accordingly with the following terms and conditions:
 - Affiliation granted is strictly provisional and only for the academic year 2023-24.
 - Selection and admission should be in accordance with the rules and regulations of the University/ Government and the directions issued by the University/Government from time to time.
 - As per the directions of the Hon'ble Supreme Court of India in WP (C) 656/1998, the institution should take appropriate measures for the prevention of ragging, in any form.
 - Conduct of University Examinations of any sort, including that of S.D.E is compulsory and binding on all
 colleges affiliated to the University of Calicut.

• Violation of any of the above may lead to the cancellation of affiliation.
